### BRIDGETON CITY COUNCIL MEETING MINUTES August 15, 2023

A meeting of the Bridgeton City Council was held on Tuesday, August 15, 2023 5:30 p.m., at the City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Bethea.

The Statement of Meeting Notice was read by Deputy Municipal Clerk, Miriam Garcia;

Invocation and Flag Salute was led by Councilman Gonzalez.

### PRESENTATIONS:

### Cannabis

Joseph Vupnik and Alan Trzuskoski-representing Cannabis Incubator

Alan Trzuskoski-stated that Cannabis incubator is designed to help small businesses start, grow and create an anchor in the City of Bridgeton and that they provide entrepreneurs with resources, guidance, and infrastructures through the whole process.

Alan Trzuskoski commented that they generated 7 conditional licenses and submitted 3 conditional conversions to the State.

Alan Trzuskoski stated that they purchased property 7 North Industrial, Block 189, Lot 3.03 and that they are working on a site plan to join Block 189, Lots 3.03 and 3.04. and upon possession of the property for Phase 1 they are looking into developing about 150,000 square feet of various style of greenhouses on Buckshutem and Burlington Road and Phase 2 will include 60,000 square feet indoor cultivation and manufacturing facility.

Alan Trzuskoski stated that in order to proceed at Buckshutem Road the CCIA needs City's approval to engage in the project.

Council President Bethea-questioned why the CCIA need's the City's approval.

Business Administrator, Kevin Rabago-responded that the Zoning and City Code will need to be amended in order to allow cannabis on that site.

Business Administrator, Kevin Rabago further stated that the CCIA does not want to move forward with the proposal unless the City approves.

Council President Bethea-stated that the Cannabis Committee will reconvene to discuss the matter and will get back with their recommendations.

Council President Bethea further stated that Council has made it very clear that they want Buckshutem Road site to be Economic Development.

Ebony Maisonet-introduced herself as the owner of E-Quality Cannabis and stated she will be bringing operation into 1 Glass Street in Bridgeton.

Ebony Maisonet stated that 1 Glass Street has 8 different buildings and she would like to purchase one of the buildings.

#### MINUTES:

Council President Bethea presented the City Council Meeting Minutes of July 18, 2023. It was moved by Councilman Gonzalez and seconded by Councilwoman King that said minutes be approved and to dispense with the reading of said minutes as all members have received copies.

The motion carried unanimously.

Council President Bethea referred to the Mayor, Business Administrator and Solicitor for their reports.

Mayor Kelly stated that Business Administrator, Kevin Rabago and Mayor Kelly have been in contact with Governor's office regarding making the necessary improvement to ensure safer conditions on Route 49.

Mayor Kelly further stated that Police Chief Gaimari has requested a stop light on Route 49 and that NJ Transit is considering a bus stop along Route 49.

Mayor Kelly stated that the bridge entrance of the park will be completed by the end of September.

Mayor Kelly reported that Senator Testa has been pressing in getting South Ave Culvert completed and that they are waiting for the engineer's final approval.

Business Administrator, Kevin Rabago –Introduced Dave Peterson as the Acting Director of Water/Sewer Department and stated it will be permanent once his credentials are finalized in October.

City Solicitor, Michele Gibson - None at this time.

Council President Bethea called upon Mayor and Councilmembers for the retirement presentation of Judge Witcher.

Council President Bethea stated it is tough to salute Judge Witcher as he did an outstanding job as the Municipal Court Judge for the City of Bridgeton.

Council President Bethea read part of the Resolution No. 179-23 Recognizing the Honorable Jason D.
