### **MINUTES:**

Council President Bethea presented the City Council Meeting Minutes of August 15, 2023. Council President Bethea requested Council/Committee Liaison Reports:

### **PUBLIC PORTION:**

Ms. Trinidad stated that the proposed Ordinances regarding alcohol in public are long overdue. She shared that she has personally called the Police Department regarding drunkenness and fights and understands that the Police Department could only do so much at that time.

Ms. Trinidad asked about marijuana odors in public. She asked if this will eventually be looked into and possibly an Ordinance put in place.

Ms. Trinidad stated that the intersection of Atlantic and Lincoln needs a 4-way stop in place. She explained that there are accidents at this location all the time. She added that speeding is a big issue here.

It was moved by Councilwoman DeQuinzio and seconded by Councilwoman King that said application be approved and filed, which motion carried unanimously.

#### REPORTS:

Council President Bethea announced there were two (2) reports for approval.

It was moved by Councilwoman King and seconded by Councilwoman DeQuinzio that said applications be approved and filed, which motion carried unanimously.

Council President Bethea called upon Mayor Kelly for comments:

Council President Bethea – Announced the sudden passing of Temple University President.

Council President Bethea congratulated all that were celebrating Hispanic Heritage Month.

Council President Bethea stated he is eager to hear the updates on the Firehouse project.

Council President Bethea stated that he will be unable to attend the clean-up this Saturday as he will be traveling to the University of Michigan for the Homecoming game against Rutgers.

Council President Bethea stated that he also had a conversation with the auditors and commended the CFO and her team for a job well done. Council President Bethea stated he has some concerns regarding the American Rescue Funds. He added that he does not want the City to lose these funds.

Council President Bethea responded to some of Ms. Trinidad's concerns brought forward at the Public Comment portion. He stated that she brought up many valid concerns. He stated that there were many individuals using the fountain plaza site as a place to drink among other things and that it was not a pretty sight. He explained that the City is trying to be aggressive to deal with the situation.

Council President Bethea addressed Ms. Trinidad's suggesting of a crosswalk for pedestrian traffic on Commerce by the plaza. He explained that the increase of vehicle traffic could be because of the bridge closing. He stated that hopefully with the reopening of the bridge come the end of the month, the traffic increase will be eased. Council President Bethea stated that a crosswalk in that area is a valid idea and is something worth looking into. Council President Bethea explained that Council and the City have looked at other locations such as Route 49 located by the Wawa for signage and/or crosswalk lighting so another tragedy does not take place.

Council President Bethea agreed with the Cannabis smell issues and explained that it is a tricky situation as the use of it is legal but with some restrictions in place. He asked that the Cannabis look into this and bring their findings back to Council.

Council President Bethea thanked all 1<sup>st</sup> Responders – Police Department, Fire Department and all Public Servants for their outstanding jobs.
