

CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Tuesday, July 21, 2015 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by President Surrency.

The Statement of Meeting Notice was read by Municipal Clerk, Darlene J. Richmond, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

Pres. Surrency presented the City Council Meeting Minutes of July 7, 2015 and Work Session of July 7, 2015, Executive Session of July 7, 2015.

It was moved by Mr. Zapolski and seconded by Mr. Spence that said minutes be approved and to dispense with the reading of said minutes as all members received copies which motion was carried.

Pres. Surrency announced no Ordinances for first reading.

Pres. Surrency announced this is the time and place set forth for the public to address Council with their comments on the consent agenda items or any other matter.

It was moved by Ms. Lugardo-Hemple and seconded by Mr. Edwards that the meeting be opened to the public for anyone desiring to be heard, which motion was carried.

Pres. Surrency opened the meeting to the public.

Mr. Michael Abbott, East Commerce, commented that he agreed with Mr. Zapolski concerning the Library and also expressed concern over employee protection at the Library.

Ms. Courtenay Reece, Director Bridgeton Library, reported that a security system is being placed in the Library and also suggested partnering with the Board of Education as Millville does during the hours children would be using the Library.

No one else desiring to be heard, it was moved by Ms. Lugardo-Hemple and seconded by Mr. Edwards that the public portion be closed, which motion was carried.

Pres. Surrency closed the public portion of the meeting.

Pres. Surrency announced all matters listed under the consent agenda J-1 through J-14 will be enacted upon by one motion unless a Council member desires to discuss an item; in that case the item will be removed from the consent agenda and acted upon separately. Item J-14 was added to the Agenda during the Work Session and items J-8 and J-10 were removed.

Informed those present of the Ten Million dollar check the City received from New Jersey Department of Redevelopment Authority for Renewable New Jersey and lastly presented the concept for the Free Little Library which will promote reading.
