

CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Tuesday, April 21, 2015 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Jack Surrency.

Mr. Michael Abbott expressed concern regarding the Library being open and Main Street the need to check the Bylaws that Main Street is designed to be self sustaining after a certain period of time

Mr. George McLaughlin submitted a list of suggestions for our City Park which he also distributed to Council.

Mr. Tom Martin, expressed concern over Port Authority documents and expenditures

Ms. Jamie Warner expressed concern regarding Library, Main Street, and Cumberland County Development.

Father Vincent Quest, Pastor of the Parish of the Holy Cross, speaking to Council to urge our General Assembly, by passing a Resolution tonight, to pass legislature that will allow undocumented residents living in New Jersey, our community, here to drive legally

Individuals spoke in regards to licensing undocumented individuals also were: Cynthia Garcia, Martha Torres, Gudelia Mandragon and Arvino Alvarer (The Council Chambers was full, standing room only with those in support of the permit for driver's licenses.)

Mr. Nick Ott, Twin Oaks Drive, registered complaint on the Tax Assessment Revaluation on his property he received.

No one else desiring to be heard, it was moved by Mr. Spence and seconded by Mr. Zapolski that the public portion be closed, which motion was carried.

Pres. Surrency closed the public portion of the meeting.

Mayor Kelly addressed Council regarding the licensing of undocumented residents urging Council to adopt a Resolution tonight which he presented in support of this legislation and that it be forwarded to General Assembly in Trenton.

Council agreed to place that Resolution n the consent agenda tonight which was accepted by a thunderous applause. from those present.

Pres. Surrency announced all matters listed under the consent agenda J-3 through J-15 will be enacted upon by one motion unless a Council member desires to discuss an item; in that case the item will be removed from the consent agenda and acted upon separately. Item J-1 and J-2 was removed from the Agenda and will be acted upon separately Item J-14 as removed from agenda during Work Session. Added to the agenda was J-15. during Work Session and item J-16 was added to the Consent Agenda during the Council Meeting...

Upon motion by Ms. Lugardo-Hemple and second by Mr. Edwards RESOLUTION NO. 123-15, authorizing amendment to shared service agreement with CCIA for solid waste disposal, Recycling Program Facilities was adopted by roll call vote with Pres. Surrency abstaining. The original resolution may be found in the Resolution Book.

Upon motion by Ms. Lugardo-Hemple and second by Mr. Edwards RESOLUTION NO. 124-15, authorizing amendment of settlement of litigation New Jersey Ethanol, LLC

was adopted by roll call vote with Mr. Spence and Mr. Zapolski voting “No”. The original resolution may be found in the Resolution Book.

Pres. Surrency thanked everyone for coming out.

It was moved by Mr. Spence and second by Mr. Zapolski to reconvene to the Executive Close Session, which motion was carried by unanimous roll call vote.
