

## CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Tuesday, March 19, 2013 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Gladys Lugardo-Hemple.

At this time presentation of a proclamation was made by the Mayor Kelly to Cosmo Terrigno, recognizing fifty years of his bakery being in business in the City.
