

## CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Wednesday, June 5, 2013 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Gladys Lugardo-Hemple.

The Statement of Meeting Notice was read by Clerk, Darlene J. Richmond, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

Pres. Lugardo-Hemple presented the Public Session minutes from the Meeting of May 21, 2013 and the Work Session Minutes of May 21, 2013.

It was moved by Mr. Zapolski and second by Mr. Surrency to dispense with the reading of said minutes as all members received copies and said minutes be approved as received.

Lugardo-Hemple announced that there is no Ordinance for first reading or second reading Ordinance.

Pres. Lugardo-Hemple announced this is the time for comments on the consent agenda or any other matter of concern the public desires to address Council.

It was moved by Mr. Spence second by Mr. Surrency that the meeting be opened to the public for any one desiring to be heard, which motion was carried.

Pres. Lugardo-Hemple opened the meeting to the public for anyone desiring to be heard.

Mr. Ted Uber, Lincoln Street, inquired about a raise for the crossing guards stating they have not had one for seven years

He was informed that it would be looked at after figures are received from the Administrator.

Mr. Mike Abbott, posed inquires regarding Resolution J-10 regarding who would be in charge of rental properties and was informed that the agency would have the responsibility.

Mr. Abbott also commented on illegal boarding houses, over crowding, and notification of housing inspections.

No one else desiring to be heard, it was moved by Mr. Spence and second by Mr. Surrency to close the public portion of the meeting, which motion was carried.

Pres. Lugardo-Hemple closed the public portion of the meeting.

Pres. Lugardo-Hemple called upon Mayor for remarks.

Mayor Kelly thanked everyone that was instrumental for the success of the Memorial Day Parade and the Splash Park opening and announced and encouraged those present and citizens to participate in the Health Walk, June 15, 2013.

Mayor also commented on the Police Department has been utilizing the City of Bridgeton for Top Gun Training and using property on Grove Street for training and he is very happy that they selected the City to do the training.

Mayor also informed Council of a Bill presented by Celeste Riley, May 20, 2013, requiring purchasers of precious metal and jewelry to submit records and report on what they buy and who they buy it from, and he asking that perhaps we can do a resolution supporting this bill.

President Lugardo-Hemple called upon Council for remarks

Councilman Thompson commented on the bill submitted and agreed with the support of the Bill by the City.

Councilman Surrency commented on the success of the Splash Park Opening and informed everyone present that Saturday is Hazard Waste Day from 8 to 2 they can bring their hazardous waste to the County Improvement Authority for disposal.

Councilman Zapolski commented that you can also bring your hazardous waste on any Saturday to the convenience center on Florida Avenue

Councilman Spence no comments.

Pres. Lugardo-Hemple commented on success of the Community Yard Sale. She is also in support of the bill by Assemblywoman Riley.

Thanked everyone for coming.

Mayor announced gun buy back taking place on Saturday, eight to eight at St. Andrews Church, may receive up to \$250.

There being no further business to come before Council it was moved by Mr. Spence and second by Mr. Zapolski to adjourn the meeting which motion was carried.
