

CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Tuesday, December 4, 2012 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Gladys Lugardo-Hemple.

The Statement of Meeting Notice was read by Deputy Clerk, Mary L. Kimble, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

Pres. Lugardo-Hemple presented the Public Session minutes from the Meeting of November 20, 2012

BOND ORDINANCE PROVIDING FOR THE ACQUISITION OF VARIOUS PUBLIC WORKS EQUIPMENT IN AND BY THE CITY OF BRIDGETON, IN THE COUNTY OF CUMBERLAND, NEW JERSEY, APPROPRIATING \$80,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$76,000 BONDS OR NOTES OF THE CITY TO FINANCE PART OF THE COST THEREOF.

BOND ORDINANCE PROVIDING FOR THE REPAVING AND RESTORATION OF VARIOUS ROADS IN AND BY THE CITY OF BRIDGETON, IN THE COUNTY OF CUMBERLAND, NEW JERSEY, APPROPRIATING \$350,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$332,500 BONDS OR NOTES OF THE CITY TO FINANCE PART OF THE COST THEREOF.

Mike Abbott, Bridgeton, told Council that he agrees with the first change, but the second position has already been given to the Fire Chief, who was compensated for this position. If someone else is now going to be in that position, is money going to be taken away from the Chief for giving up the position?

Mr. Goodreau stated that investigations are still being conducted, and when they are finished, cleanup will begin.

Mr. Abbott commented that Church Street is a very dangerous street, he saw a car almost hit a school bus. Cars are going too fast. Something should be done before someone gets hurt.

Mr. Abbott had a question about agenda item G-2, regarding department heads.

Pres. Lugardo-Hemple told Mr. Abbott that that item has been pulled from the agenda.

Carl Hemple, Bridgeton, the Bridgeton Little League has sent equipment to the Little League organization overseas.

People going to El Rodeo on Pearl Street are parking up to the curb line and it is hard to see traffic coming south on Pearl Street from Madison Street.

No one else desiring to be heard, it was moved by Mr. Zapolski and second by Mr. Spence to close the public portion of the meeting, which motion was carried.

Pres. Lugardo-Hemple closed the public portion of the meeting.

It was moved by Mr. Thompson and second by Mr. Spence that said reports be received and filed which motion was carried.

Pres. Lugardo-Hemple called upon the Mayor for comments.

Mayor Kelly stated new bus system is moving along. Ridership is up 22%, without advertising. He attended the Festival of Lights, it was very nice, and entertaining, and something that the city should be proud of.

Pres. Lugardo-Hemple called upon Council remarks.

Councilman Zapolski stated he was at the Festival of Lights; activities were very nice, very well put together. Well attended. He commended the volunteers who worked on the event. Councilmembers will be supporting the Salvation Army by ringing the bells at C-Town on December 15th.

Councilman Spence – several activities have taken place since the last meeting, the last one being the Festival of Lights, Fridays attendance was over 600 people, and on Saturday there were over 1,300 people attend. He appreciates all the work of the volunteers, and the city employees, who take pride in their jobs. Also the parade was successful, as well as the Holiday House Tour. Thank the volunteers who have helped in these events, and wish them a Merry Christmas.

Pres. Lugardo-Hemple – House tour was really beautiful. People there from Delaware. She hopes that the people who live here appreciate what is here in the city. She attended the Festival of Lights, food and activities were fantastic. She wishes it could be up the whole month of December, because families from all over would enjoy it.
