

CITY COUNCIL MEETING

A meeting of the Bridgeton City Council was held on Tuesday, March 17, 2015 at 6:30 p.m., City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Council President Jack Surrency.

The Statement of Meeting Notice was read by Municipal Clerk, Darlene J. Richmond, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

1. By posting notice of said meeting on the bulletin board at City Hall Annex, 181 East Commerce Street, Bridgeton, New Jersey on March 13, 2015, at 4:30 pm
2. By mailing such notice to the News of Cumberland County and the Press on March 13, 2015, at 4:30 p.m. Invocation and flag salute was led by Councilman Zapolski.

Pres. Jack Surrency presented the City Council Meeting Minutes of March 3, 2015 and Work Session of March 3, 2015, also Executive Session Minutes of March 3, 2015.

It was moved by Mr. Spence and seconded by Mr. Zapolski to dispense with the reading of said minutes as all members received copies and that said minutes be approved, which motion was carried.

Pres. Surrency announced one Ordinance for first reading.

The Clerk read an ordinance entitled:

ORDINANCE CREATING THE BRIDGETON JOINT MUNICIPAL COURT

It was moved by Mr. Spence and second by Ms. Zapolski that the ordinance be adopted on first reading and that second reading, public hearing and final consideration be held on April 7, 2015 which motion was carried by unanimous roll call vote

The Clerk announced Ordinance adopting Chapter 350 of the Municipal Code was removed from the agenda during the Work Session.

Pres. Surrency announced one Ordinance for second reading:

The Clerk read an ordinance entitled:

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE CITY OF BRIDGETON, IN THE COUNTY OF CUMBERLAND, NEW JERSEY, APPROPRIATING \$1,220,00 THEREOF AND AUTHORIZING THE ISSUANCE OF \$1,159,000 BONDS OR NOTES OF THE CITY TO FINANCE PART OF THE COST THEREOF.

It was moved by Mr. Edwards and second by Ms. Lugardo-Hemple that the meeting be opened to the public for a hearing on the matter which motion was carried.

Pres. Surrency opened the meeting to the public for anyone desiring to be heard on this ordinance and this ordinance only.

No one desiring to be heard, it was moved by Mr. Edwards and second by Ms. Lugardo-Hemple that the public portion of the meeting be closed which motion was carried.

Pres. Surrency closed the public portion of the meeting.

It was moved by Mr. Edwards and second by Ms. Lugardo-Hemple that this be considered that third and final reading of said ordinance and that the ordinance be taken up for adoption or rejection by roll call vote.

It was moved by Ms., Lugardo-Hemple and seconded by Mr. Spence that the meeting be opened to the public for anyone desiring to be heard, which motion was carried.

Mr. Michael Abbott, East Commerce Street, expressed concern over the Ethanol Plant, protest march allowed with no permits issued and cars racing on the streets.
