

## CITY COUNCIL REORGANIZATION MEETING

A meeting of the Bridgeton City Council was held on Tuesday, July 3, 2012, 12:00 Noon, City Council Chambers, City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey.

The meeting was called to order by Municipal Clerk, Darlene J. Richmond

The Statement of Meeting Notice was read by Municipal Clerk, Darlene J. Richmond, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

1. By posting notice of said meeting on the bulletin board at City Hall, 168 East Commerce Street, Bridgeton, New Jersey on June 29, 2012, at 4:30 p.m.
2. By mailing such notice to the Bridgeton News and the Press on June 29, 2012, at 4:30 p.m." The moment of silence and flag salute was led by Councilman Spence.

Clerk called for nomination of Temporary President.

It was moved by Mr. Spence and second by Mr. Surrency that Councilman Spence be nominated as Temporary President with no other nominations; Councilman Spence was elected Temporary President.

Clerk announced Councilman Spence as Temporary President.

Temporary Pres. Spence called for nomination of Council President for the 2012/2013 Year.

It was moved Mr. Zapolski and second by Mr. Thompson that Councilwoman Gladys Lugardo-Hemple be nominated as City Council President year 2012/2013 with no other nominations and by unanimous roll call vote Councilwoman Lugardo-Hemple was elected as City Council President for the year 2012/2013.

Temporary Pres. Spence presented 2012/2013 City Council President Elect Gladys Lugardo-Hemple the gavel.

Pres. Lugardo-Hemple announced no minutes.

Pres. Lugardo-Hemple announced no Ordinances for first reading.

Pres. Lugardo-Hemple announced no Ordinances for second reading.

Pres. Lugardo-Hemple announced this being the time place set for public portion on the consent agenda or any other concerns.

It was moved by Mr. Spence and second by Mr. Surrency that the meeting be opened to the public for anyone desiring to be heard, which motion was carried.

Pres. Lugardo-Hemple opened the meeting to the public for anyone desiring to be heard.

Mr. Carl Hemple gave a report on the Little League and invited everyone to their July fourth activities.

Mr. Francisco Torres congratulated Gladys Lugardo-Hemple being elected as Council President and thanked Council for voting for her, he knows she will do a good job.

Mr. Ed Gajate congratulated Gladys Lugardo-Hemple on becoming Council President and commented on the excellent job Public Works Department did during the storm and the clean up that is taking place, kudos to Director Dean Dellaquila.

Mr. Ed Bethea congratulated Mrs. Lugardo-Hemple and echoed the remarks concerning the Public Works Department.

Ms. Gloria Cortez commented she is proud of Ms. Lugardo-Hemple happy for her and that Director Dellaquila is the best.

Mr. Samuel Serata commended City Council and that it is nice to have a rainbow coalition on City Council and see the leadership of City change; recognize some of the different factors that constitutes our community.

He congratulated Gladys Lugardo-Hemple on her achievement and congratulated the other members of Council.

Mr. Serata recognized the Department of Public Works for the good job they are doing in the City.

Mr. Serata further stated that we are the County seat and the most illiterate County in the State of New Jersey. Pres. Lugardo-Hemple announced no applications.

Pres. Lugardo-Hemple announced no reports.

Pres. Lugardo-Hemple called upon the Mayor for comments.

Mayor Kelly congratulated Gladys Lugardo-Hemple for becoming our newest Council President and thanked her for taking up the challenge and he looks forward to working with her.

Pres. Lugardo-Hemple called upon Council for comments.

Councilman Thompson congratulated Ms. Lugardo-Hemple that she has made a lot of strides. Bill has done a tremendous job and he admires the input Mr. Zapolski has done this past year; and he is proud of being a part of this Council and now with her taking the helm the first bilingual he knows she will do a great job and he is very proud of her.

He concurs with everyone's comments about the storm and the Library we must all work together.

Councilman Surrency thanked Councilman Zapolski; he did a great job this past year and hopes he continues the same throughout our tenure here.

Councilman Surrency congratulated Mrs. Lugardo-Hemple as becoming President it is a great honor to serve with her, and informed her to feel free to call upon him for any assistance.

Councilman Zapolski commented first and foremost he would like to congratulate Mrs. Lugardo-Hemple. It was a pleasure to nominate her and he certainly feels she will do an excellent job, and he is here to help her where ever he can.
