

## CITY COUNCIL REORGANIZATION MEETING

A meeting of the Bridgeton City Council was held on Tuesday, July 1, 2014, Noon, City Council Chambers, City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey.

The meeting was called to order by Municipal Clerk, Darlene J. Richmond

The Statement of Meeting Notice was read by Municipal Clerk, Darlene J. Richmond, "Adequate notice of this meeting pursuant to N.J.S.A. 10:4-6 giving the time, date, location and agenda to the extent known has been given in the following manner:

1. By posting notice of said meeting on the bulletin board at City Hall, 168 East Commerce Street, Bridgeton, New Jersey on June 27, 2014, at 4:30 p.m.
2. By mailing such notice to the South Jersey Times and the Press on June 27, 2014, at 4:30 p.m." The Invocation and flag salute was led by Councilwoman Lugardo-Hemple.

Clerk called for nomination of Temporary President.

It was moved by Mr. Surrency and second by Mr. Thompson that Councilwoman Lugardo-Hemple be nominated as Temporary President with no other nominations; Councilwoman Lugardo-Hemple was elected Temporary President.

Clerk announced Councilwoman Lugardo-Hemple as Temporary President.

Temporary Pres. Lugardo-Hemple called for nomination of Council President for the balance of Year 2014.

It was moved Mr. Thompson and second by Mr. Spence that Councilman Surrency be nominated as City Council President year 2014 with no other nominations and by unanimous roll call vote Councilman Surrency was elected as City Council President for the balance of the Year 2014.

Temporary Pres. Lugardo-Hemple presented City Council President Elect Jack Surrency the gavel for the balance of the Year.

Pres. Elect Surrency thanked Council for their support and electing him as the next President.

Pres. Surrency presented the minutes of June 17, 2014 and June 24, 2014 Council Meetings, and Work Session Minutes of June 17, 2014 and June 4, 2014.

It was moved by Ms. Lugardo-Hemple and Second by Mr. Spence to dispense with the reading of said minutes as all members having received copies and minutes be approved as received which motion was carried.

Pres. Surrency announced no Ordinances for first reading.

Pres. Surrency announced the Ordinances for second reading were removed and will be re-advertised for public hearing and final consideration on July 15, 2014.

Pres. Surrency announced this being the time place set for public portion on the consent agenda or any other concerns.

It was moved by Mr. Spence and second by Mrs. Lugardo-Hemple that the meeting be opened to the public for anyone desiring to be heard, which motion was carried.

Pres. Surrency opened the meeting to the public for anyone desiring to be heard.

No one desiring to be heard, it was moved by Mr. Spence and second by Mrs. Lugardo-Hemple to close the public portion of the meeting which motion was carried.

Pres. Surrency closed the public portion of the meeting.

Pres. Surrency announced no applications.

Pres. Surrency announced no reports.

Pres. Surrency called upon Mayor Kelly.

Mayor Kelly thanked Councilwoman Lugardo-Hemple for her leadership for the past two years being Council President. She had some hard decisions to make and he appreciated her leadership and her continuing work for the City of Bridgeton and making it a better place to live in and looks forward to continue working with her.
