# BRIDGETON CITY COUNCIL MEETING MINUTES January 17, 2023

A meeting of the Bridgeton City Council was held on Tuesday, January 17, 2023 5:30 p.m., at the City of Bridgeton Police and Municipal Court Complex, 330 Fayette Street, Bridgeton, New Jersey in Council Chambers.

The meeting was called to order by Deputy Municipal Clerk, Miriam Garcia.

# ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRIDGETON AMENDING ORDINANCE 22-34 FIXING THE SALARIES AND RATES OF CERTAIN OFFICERS AND EMPLOYEES

It was moved by Councilman Gonzalez and second by Councilwoman Dequinzio this be considered the second reading of said ordinance and the meeting be opened to the public for a hearing on the matter which motion was carried unanimously.

#### **PUBLIC PORTION:**

Council President Bethea opened the meeting to the public for anyone desiring to be heard. It was moved by Councilman Gonzalez motioned and seconded by Councilwoman DeQuinzio the public portion be opened.

Alan Trzuskoski of 7 N. Industrial Blvd-gave a quick update and stated that they are working on finalizing everything for the conversion application which involves documenting the contract and everyone involve in the business. Alan also stated on the incubator side of things that the planning board will be ratifying plans for property located at 7 North Industrial Blvd. and once it gets approved next month there will be a purchase of sale.

Eddie Bartee-stated he was driving the other night leaving Wawa and was headed on east avenue and realized that he was being followed. He continued that once he made a left turn into Martin Luther King Jr. Way on the end of the road before getting to Florida Ave, he was pulled over by an officer for not signaling one hundred feet before getting to the stop sign. He added that there is no sign that states where the hundred feet marker is and you can only make a left hand turn on that road. Mr. Bartee stated the city should do something because there is no other road going that way that is accessible to the public and therefore should be a sign that says left hand turn only.

Andrea Gillis of 270 Cohansey-commented that the material being used to fix the pot holes should be looked into because all streets are still cracking up.

Andres Gillis- provided some safety concerns such as the need for a red light at North Laurel Street and Pearl Street. She stated that there are streets that are dangerous and it needs to be looked at.

Esaul Martin- stated that they hired a new Executive Director for Bridgeton Housing Authority Ivy Melendez from Vineland New Jersey.

Chavela Green Alston 335 Colfax Street-stated that there is a young man in the community by the name of Devon Parker who picks up litter seven days a week in the rain and cold and wanted to know what the City can do for him to show that we appreciate him for what he is doing in the area.

Chavela Green Alston- Discussed safety concerns for children crossing the road to get to the Wawa. She suggested the speed be lowered in that area or signs put up regarding pedestrians crossing.

Mayor Kelly-stated that there is a resident on 72 South Pine Street who has some concern that they are addressing with the Code Enforcement Department and that she came today to speak about her dilemma.

Laquanda Bradshaw 72 Pine Street-stated she has been renting her home for four years and she has not been able to get any maintenance in her property. She stated that on December 24, 2022 her pipes busted on her walls and the landlord did not come out to help. Ms. Bradshaw stated that her home has been rendered as uninhabitable.

Administrator Kevin Rabago-commented that property 72 Pine Street has six pending summonses for a multitude of violations that where citied and not corrected.

Council President Bethea-commented that there are couple of remedies to assist her until the situation is resolved. Council President Bethea stated that he is glad that the City is going to hold this particular landlord accountable. Council President Bethea also stated that they take this very serious with regard to safeguarding our citizens.

William Robinson-stated that he moved to Cumberland County a year ago and that he started a non-profit organization called "A Better Cumberland County" and the goal is to employ one to eighty kids in Cumberland County yearly round. Mr. Robinson continued that they partnered with local businesses to develop trade training to youngsters from fourteen through eighteen years of age. He also stated that that there is a community service where they develop projects to serve their community and help them implement their projects.

Rafael Cruz 481 Harvest Lane-Commented to possibly put a City Ordinance to require a license to become a landlord in Bridgeton.

With no one else desiring to be heard, it was moved by Councilman Edwards and seconded by Councilwoman Dequinzio the public portion be closed, which motion was carried. Council President Bethea closed the public portion of the meeting.

#### **CONSENT AGENDA:**

Council President Bethea announced all matters listed under the consent agenda; M-1 through M-14 will be enacted upon by one motion unless a council member desires to discuss an item, in which case the items will be removed from the consent agenda and acted upon separately.

Council President Bethea called upon the Deputy Municipal Clerk to read the Resolutions of the Consent Agenda.

**RESOLUTION NO. 18-23,** authorizing the City of Bridgeton to award a contract to Municipal Maintenance Co. for Emergency Generators and Automatic Transfer Switches for Well #2 and Pump Stations #3, #4 and #8, in the amount not to exceed \$583,809.00.

**RESOLUTION NO. 19-23,** of the City Council of the City of Bridgeton approving the consolidation of certain City of Bridgeton bank accounts.

**RESOLUTION NO. 20-23,** of the City Council of the City of Bridgeton approving use of a portion of American Rescue Plan Act (ARPA) Funding for the purchase of an (one) ambulance for the Fire/EMS Department consistent with uses outlined in 31 CFR Part 35.

#### SCHEDULE OF BILLS:

It was moved by Councilman Gonzalez and seconded by Councilwoman Dequinzio that said applications be approved and filed, which motion carried unanimously.

## Council President Bethea called upon Mayor Kelly for comments:

**Mayor Kelly** – Spoke about Devon Parker and stated that Devon is one of four individuals that goes out daily in our City to pick up trash and that Mayor Kelly decided to asked all four individuals to come in February so they can be recognized for what they do.

### Council President Bethea called upon Council for comments:

Councilwoman DeQuinzio – Stated that today's meeting has been an eye opener with what Ms. Bradshaw is going through.

Councilwoman DeQuinzio- addressed Mr. Cruz and stated that the licensing of landlords was proposed about two years ago and it was shot down by a landlord.

**Councilwoman King** – stated that there are lot of properties that are not up to par and that many families are living in a condition that should not be. She continued when it comes to private owners their hands are tied.

Councilwoman King-stated as a City we can look into doing a Pilot Program where they can look into these things and have residents come and feel free to express whatever it is that they are going through.

Councilman Gonzalez-commented that as a former landlord, he can't see how some of these landlords don't take care of their properties that are supposed to be an investment for them. He continued that they should also care for the community and want the best for it.

Councilman Gonzalez- stated he is looking forward to "A Better Cumberland County" working with our youth, along with other programs.

Councilman Gonzalez-stated they are looking forward in meeting the new Executive Housing Director.

Councilman Edwards –appreciated everyone that had something to say.

Councilman Edwards- stated that Mr. Ed Bartee is a stand-up guy and is saddened to hear that he is being profiled in the City of Bridgeton.

Council Edwards- Stated that interviews started for a new recreation director and that there are two candidates.

Council Edwards-addressed Andrea Gillis and stated that they will find the proper materials to fix the pot holes.

Councilman Edwards-stated that Devon Parker should be recognized for picking up trash.

Council Edwards-thanked Mr. Robinson for introducing himself and "A Better Cumberland County" and that he is looking forward to working with him.

**Council President Bethea** – stated that he wants our residents to respect the police and certainly police to respect our residents. He continued that it has to be a given and take.

Council President Bethea addressed Ms. Gillis about the pot holes and stated that we do have a lot of pot holes. He added that he wishes we can pave all the streets in town but we don't have the funds for it. He continued that we do our best with the money that we receive to fill those pot holes. He stated when you have situations where pot holes are really bad, you can notify Public Works, Mr. Rabago, Councilmembers and the Mayor and they will make them aware to try their best to get out there and fill the pot holes.

Council President Edward Bethea stated he is very excited about new leadership at the Housing Authority.

Council President Edward Bethea addressed Ms. Bradshaw and stated that he is devastated about her story.

Council President Edward Bethea stated that the City-Wide Clean-Up is twice a year and that he is very pleased to hear that Devon Parker walks around with his bucket to pick up trash and he should be acknowledged for his work and contribution for what he does for our City.

Council President Edwards expressed his concerns with on Route 49. He stated that he has seen other municipalities doing a crossing sign to slow people down when kids are around and perhaps is something to look into having a conversation with DOT about what can be done there.

Council President Edward addressed Mr. Robinson and stated he would like to have a conversation with him. He stated the City is trying to do some work force development in 2023.

Council President Bethea appreciated and thanked all 1st Responders. He also acknowledged Civil Servants for their outstanding job.

#### **ADJOURNMENT:**

There being no further business before Council, it was moved by Councilman Edwards and seconded by Councilwoman Dequinzio to adjourn the meeting which motion carried unanimously.

Council President Bethea adjourned the meeting which ended at 6:39 p.m.
