Kevin Rabago, Development Planning

Three major projects working on one being the Ferracute Property with Agri-global have no progress after several meetings.

Block 121 Lot 8, property behind City Hall is active J&J Corporation for retail and commercial business but nothing to bring before Council at this time.

Phoenix Redevelopment, areas we have had an interest from one developer who is the process of preparing a plan to come a present to Council.

He is working with Main Street and Chambers for some initiatives for down town and exploring upstairs downtown living. Also on working on some of the empty buildings down town on making them more productive sites.

The Nail House working on with CHOBA who will be here at the next meeting bring you up to date on that.

Councilwoman Lugardo-Hemple asked if the developers for Block 121 Lot 18 were the same one they came before and Mr. Rabago informed here they were.

Councilman Zapolski questioned status of New Jersey Ethanol?

Administrator stated all the landscaping is done on the site. They are recruiting manager and employees no projection of start. Solicitor stated agreement was not operation.

Zapolski stated he is not overly confident that this will be a viable adventure.

Discussion concerning Economic Development Plan and Marketing Plan

Administrator stated are part of the Vision Plan.

Councilman Zapolski stated the need to drive Economic Development in the City. A Vision Plan is not a Economic Plan.

Discussion concerning the need for an Economic Development Plan implementing a strategy for bringing business and revenue in the City should be top priority.

Also the down town blighted area clean-up the need of more enforcement regarding vacant building owners and window clean-up.

- J-7 Resolution Mobile Food Concession in Park, Councilman Zapolski pointed out that this should be made clear this is not a peddler permit.
